
What Resolution Should I Choose?
All resolutions provide very high quality scans for viewing on the computer. The scan resolution is more relevant if you plan on enlarging the photos later for printed projects. The higher resolution chosen allows you to enlarge the picture without pixilation up to the size indicated. As the scan resolution increases, so does the file size.

Enhancement, Dust & Scratch Removal, Orientation
All slides scanned will be automatically enhanced for contrast, color and tone and fixed for proper orientation. In addition, our equipment uses Infrared Sensor technology to detect and remove dust & minor scratches.

TV Viewable Slideshow
Most DVD and Blu-ray players do not play data discs. If you would like an additional disc that will play on your TV as a movie, choose this option. TV Viewable Slideshow Disc's can display approximately 1200 slides per DVD Disc or 3500 slides per Blu-ray Disc. Choose the Blu-ray option for the highest quality.

Additional Copies & Digital Storage
DVD Archival Grade M-Discs are the standard for long term data storage. However, for additional copies, we also offer you the option to provide your own USB Storage device (free), or you can have us quote the price of an appropriate sized storage device for you.
